# OPPORTUNITIES AND CHALLENGES FOR MSMEs AND CRAFTS FOR A STABLE AND SUSTAINED GROWTH

#### From the written statements and reports submitted during 2023

The World Union of Small and Medium Enterprises Association pursues the aim of representing and supporting the interests of SMEs and Crafts with particular attention to countries with less developed economies and female entrepreneurship.

MSMEs are the backbone of many economies, providing employment opportunities, driving innovation and creativity, and generating wealth and income for individuals and communities.

Looking at the business world from the perspective of SMEs makes it possible to identify the drivers to stimulate growth, starting from a dimension close to everyday life, and to enhance an entrepreneurial spirit that generates development and work opportunities in line with social changes, market evolution and a more sustainable dimension.

Social development is essentially about working together to improve the well-being of each individual member of society, so that they have the opportunity to realize their full potential. The success of the Enterprise itself is inexorably linked to this result.

There is a growing disparity between rich and poor in developing regions around the world, much of which one must believe is largely unintentional. Correcting the course will not be easy, but it must be undertaken, nonetheless. One of the problems is the fact that a large percentage of all jobs in a given region is informal.

New support programs are needed in different fields, such as: developing entrepreneurial competencies, training entrepreneurs and qualified personnel of SMEs, promoting permanent training to improve competitiveness and employment capacity, developing digitization and digital skills, developing new financial schemes, reducing bureaucratic processes, developing specific policies oriented to the different types and groups of enterprises, developing programs for the improvement of the innovation capacity of the entrepreneurs, promoting sustainability of SMEs and circular economy.

It is also important to focus on achieving gender equality to accelerate the value placed on women in enterprises by promoting their access to finance, technology and training.



Much remains to be done in education around the world. While there is widespread access to education in most countries, the main challenge continues to be education that meets the needs of the community and/or region in addressing the complex challenges ahead, such as climate change, and identify the best solutions to achieve sustainable development goals.

Technology, digitalization and innovation are to be reminded as important factors for enterprises facing climate adaptation and energy transition, also within the value chains to which they belong.

It is essential that large corporate groups collaborate together with small businesses, as strategic partners in the path of decarbonisation and sustainable development, cooperating alongside public institutions in targeted initiatives and in a logic of mutual partnership.

In conclusion, the current global scenario requires a joint collaborative effort to accelerate the full implementation of the sustainable development objectives envisaged by the 2030 Agenda also through the contribution of businesses, improving their access to financing and sharing the best practices available to develop an inclusive and supportive environment.

# WUSME's Written Statement for the 61st Session of the United Nations Commission for Social Development (CSocD61)

As NGO accredited to the United Nations Economic and Social Council (ECOSOC), WUSME was entitled to submit a Written Statement for the 61st Session of the United Nations Commission for Social Development (CSocD61) to take place from 6 to 15 February 2023 at the United Nations Headquarters in New York with the following Priority Theme "*Creating full and productive employment and decent work for all as a way of overcoming inequalities to accelerate the recovery from the COVID-19* 



pandemic and the full implementation of the 2030 Agenda for Sustainable Development".

The document, drafted by the Permanent Commission for the Development of SMEs of the World Union of Small and Medium Enterprises (WUSME), under the guidance of the President Barbara Terenzi, the Board of Directors and the WUSME HQ, reaffirms, in its conclusion, the commitment of WUSME ready to work with all the development partners to meet the aspirations of the communities across the globe and looks forward to the results of the deliberations of this 61st United Nations Commission for Social Development.

# WUSME at the 61st session of the UN COMMISSION FOR SOCIAL DEVELOPMENT (CSOCD61)

On February 13, 2023 Dr. Annie Borello, Permanent Representative of WUSME to UN HQ in New York City, attended the 61st Session of the Commission for Social Development (CSocD61) to convey a message on behalf of the Union of Small and Medium Enterprises during the General Discussion.

In her statement, Dr. Borello highlighted how "it is essential for governments and international organizations to promote entrepreneurship with adequate public policies and to focus on women entrepreneurs, with programs supporting the development of small and medium-sized enterprises, vocational and entrepreneurial training activities, promotion of best practices, green economy, digitalization that helps to bridge physical and social gaps, and technology transfer, especially to micro, small and medium-sized enterprises operating in key sectors for the social development of emerging countries, which contributes to sustainable development goals and decreases inequality."

She also stressed how "Fostering women's entrepreneurship directly and indirectly address inequalities in a particularly effective way, contributing to the wellbeing of families, allowing the development of new childcare solutions thus preventing also criminality, child labor and trafficking."

Additional recommendations have been expressed in the written statement submitted by WUSME for the Session and officially published on the relate website.

WUSME stands ready to work with all partners that share these goals for the improvement of the conditions of communities around the world and looks forward to the results of the deliberations of the 61st United Nations Commission on Social Development.

#### WUSME At The 39th Session Of UNCITRAL WORKING GROUP I (MSMEs)

A WUSME delegation attended virtually the 39th session of UNCITRAL (the United Nations Commission on International Trade Law) Working Group I on Improving MSMEs' Access to Credit which took place in New York, February 13-17, 2023, at the UNHQ. The WUSME delegation composed by President Barbara Terenzi, Directors Dr. J.S. Juneja and Mr. Kumar and WUSME Ambassador in Chile Mr. Alessandro Bozzo, followed the proceedings and discussions held by the Delegates of the Member Countries on a draft Guide on Access to credit for micro, small and medium-sized enterprises (MSMEs), to be submitted to the Commission in July. As stated in the document, access to finance (e.g. credit, savings, payment, insurance) is essential for MSMEs throughout their life cycle. It enables entrepreneurs to start, innovate, improve efficiency and productivity and eventually expand their businesses. As noted by the World Bank, lack of or limited access to finance is the second most cited obstacle small businesses face in emerging markets. In particular, access to credit enables MSMEs to make productive investments, which are instrumental in generating income and gaining access to additional resources. Various factors may affect access to credit and the type(s) of available credit, including age of the enterprise, gender of the entrepreneur, account history of personal and business bank accounts owned by the entrepreneur, and availability of business records.

# WUSME Partner Of The 8th Annual Shakti National Convention – Empowering Women Entrepreneurs

WUSME joined the "8th Annual Shakti National Convention 2023 — Empowering Women Entrepreneurs" organized by India SME Forum with the support of the Minister for Micro, Small and Medium Enterprises of the Government of India, as International Partner.

On the occasion, WUSME President Barbara Terenzi sent a message of support to the initiative, whose main theme this year was "Promoting a sustainable ecosystem for female entrepreneurship".

In her statement, WUSME President recalled how the Organization has always supported Female Entrepreneurship and has a Permanent Commission specifically dedicated to Social Issues and Female Entrepreneurs.

"Women make up a substantial number of micro-enterprises in many countries. It is important to focus on how technology and innovation can help achieve gender equality to accelerate the value attributed to women in business and enterprise, enabling easy access to finance as necessary also to achieve the Sustainable Development Goals set in the 2030 Agenda" she recommended. In her speech, WUSME President highlighted how it is "of great importance that, this year, India has assumed the presidency of the G20 to promote and address the challenges of MSMEs also thanks to the support of Organizations and Associations acting as link between Institutions and SMEs."

On the theme of the Convention, she underlined how it is "necessary to create the tools, with the help of all parties, to encourage innovation among SMEs and achieve the sustainable development goals set in the 2030 agenda." In the document, WUSME reaffirms its commitment to protect and support female entrepreneurship also through the work of its Permanent Commission on Social Issues and Women Entrepreneurship. In recent meetings held, the Commission addressed issues related to what is happening on the ground for women entrepreneurs particuarly in underdeveloped and developing countries.

In the paper, it is highlighted how it is important to focus on how technology and innovation can help achieve gender parity to accelerate the value placed on women in business. The statement also includes general recommendations to promote an environment conducive to the goals of the UN Commission on the Status of Women such as to support the necessary changes in gender equality policy, to continue addressing global issues of inequality and put pressure on making available the resources needed such as technology, business education, ease of funding, environmental safety measures for women in business and in their communities. WUSME is ready to work with all partners sharing the goal to improve women's conditions around the world, foremost through the empowerment of female entrepreneurship.

The Convention promoted bilateral trade and partnerships on focus key sectors such as Manufacturing, Services, Green Energy, Renewable Energy, Waste Management and Sanitation, Agri-Food and Food Processing.

On the occasion, Mr. Shafquat Haider, WUSME Ambassador in Bangladesh took the floor, during the session on "Sustainable Ecosystems for MSMEs: Global Experiences, Challenges & Best Practices", to briefly introduce WUSME and highlight the importance of technology in Sustainable Ecosystems for SMEs.

#### WUSME Partner of AIM 2023 speaking at the Entrepreneurs Investment Summit

WUSME joined the *Annual Investment Meeting 2023 (AIM 2023)* held in Abu Dhabi from 8 to 10 May 2023 as International Partner, and actively contributed to the discussions focusing on SMEs related issues.

Mr. Michel Fossaert, Member of the Board of Directors, attended as official Delegate the event which gathered thousands of visitors from different parts of the world, mainly from the Middle East and Africa but also from Asia and Europe. Conferences and exhibitions took place over the four days event. The first day was devoted mainly to workshops. Wusme participated in the workshop on SMEs and access to finance.

On May 8, Mr. Fossaert spoke at the Entrepreneurs Investment Summit, held as as an integral part of the AIM and organized in association with the UNIDO ITPO office in Bahrain. The WUSME Delegate took the floor in the panel session related to "Improving SMEs Access to Sustainable Finance: Finding Innovative Solutions to Unlock Sources of Capital", which brought together Wissam Fathou from the Arab Banks Union, Pauline Koelbl from ShEquity's, Baybars Altuntas from World Business Angels Investment forum, Mohamed Hreimou Emirati Entrepreneur association and Ali Muqaibal from the Development Fund for Youth Projects. The discussion focused on innovative ways to facilitate access to financing for SMEs, such as crowdfunding, online loans and support through business angels and business creation funds. Mr. Fossaert underlined that, for already existing SMEs, it is necessary to work on credits and capital contribution. He talked about the potentials of blended capital, which brings together money from donors and private investors and insisted on the need to innovate in terms of guarantees. WUSME also paid particular attention to the African countries present at the Convention, whose delegations presented their activities or solutions on the themes of food sovereignty and security. # WUSME joined the OECD at the "SME AND ENTREPRENEURSHIP STAKEHOLDER DIALOGUE" In Paris

On the occasion of MSME Day, WUSME Board Member Michel Fossaert and WUSME Ambassador in Austria Michele ORZAN, attended the "SME and Entrepreneurship Stakeholder Dialogue" organized by OECD in Paris on 26 June 2023, in preparation of the ministerial meeting of 27-28 June 2023.

The event was aimed at further exploring the private sector's role in the context of the overarching theme of the ministerial, "*Managing the Shocks and Transitions – Future-Proofing SME and Entrepreneurship Policies*".

The event was also opportunity to assess the current situation of SMEs and entrepreneurship, identify main business priorities, opportunities and challenges, engage in a dialogue with selected Ministers, and explore an agenda for further action at the private sector level. The discussions held at the meeting helped prepare the ground for the OECD SME Ministerial Meeting on 27-28 June 2023.

The result of the discussions can be summarized as follows.

Over the past years, the global economy has suffered big shocks that have had a real impact on small and medium-sized enterprises and entrepreneurs.

While government support protected SMEs from the economic impact of the COVID-19 pandemic, new threats have emerged.

Rising geopolitical tensions and global risks, high inflation, tightening monetary and fiscal policies, labor shortages, high trade barriers and slowing integration in global value chains all contribute to a more challenging business environment for SMEs.

Now, there is an urgent need to accelerate the contribution of SMEs and entrepreneurship to the green and digital transitions and help them navigate a changing international trade and Investments landscape.

On July 29, WUSME Board Member Mr. Michel FOSSAERT spoke at the virtual conference organized by the Cameroonian NGO Think and Do Tank THE OKWELIANS.

The round table was the fourth sequence of a cycle of workshops on "REFOUNDING THE EMPLOYERS" and was dedicated to the DIASPORA, in particular to the theme of "Challenges of an inclusive representativeness, making the diaspora an essential player in the new economic cooperation". The seminar focused on "the role of diasporas in building the new employer cooperation" and their involvement within employers in responding to the challenges of our current economy. Different Speakers, representatives of Employers' organizations, Chambers of Commerce and Entities committed to promoting investment and trade in Cameroon, took the floor to bring their experiences and views.

In his introduction, Mr. Mossadek BALLY, President of the Malian Employers' Organization, gave his testimony on the restructuring of his employers' union, the role that must be played and the need to develop MSMEs in agricultural processing before being able to develop other sectors in order to rebalance social structures.

WUSME highlighted its presence in Africa, in more than 25 countries, and the support provided to African MSMEs.

Fossaert stressed the need for MSMEs to work in the framework of International Networks. The diaspora offers important assets such as talent, investment opportunities at home and connections across the world. WUSME is a good platform of contacts and opportunities for Cameroonian MSMEs to seize and is delighted to associate its action with that of the Cameroonian diaspora through The Okwelians.

#### WUSME at the 6th Edition of FITA 2023 on SME Financing Mechanisms

WUSME Special Representative and Ambassador in Tunisia Dogad Dogoui attended the 6th International Conference "*Financing Investment and Trade in Africa (FITA 2023)*, held in Tunis on 20-21 September, as Speaker on the theme "*SME financing mechanisms"*.

The 2-day Conference was organized on the initiative of the Tunisia Africa Business Council (TABC) under the patronage of the Presidency of the Republic, said TABC President Anis Jaziri.

Placed under the theme "Africa in the midst of a global crisis and the role of the private sector in sustainable and inclusive economic transformation", this event addressed several themes such as financing, climate and sustainable development, digital transformation, infrastructure, inter-African trade and regional integration.

Dogoui with Co-speakers from the Tunisian Ministry of Finance, the EBRD (UK), the Mauritanian Bank BCI and the Cred'Assur (Belgium) profitably discussed mechanisms to finance SMEs.

Dogoui's contribution focused on the absolute need to link African SMEs to public markets and private subcontracting, the primary source of their financing through supplier credit and turnover. Mr. Dogoui also insisted on the responsibilities of African states in setting up national guarantee funds to secure the commitment of commercial banks.

To him "the real development of Africa will involve the strengthening and consolidation of SMEs, providers of local jobs".

#### WUSME at the 32nd Meeting of the UN-FCCC Standing Committee on Finance

WUSME Ambassador in Chile Alessandro Bozzo attended the 32nd meeting of the Standing Committee on Finance of UNFCCC held on September 26-28, 2023 in Geneva, Switzerland and virtually.

The program provided a thorough review of the working documents in relation to the Mandates of the 27th session of the COP and the fourth session of the Conference of the Parties as a meeting of the Parties to the Paris Agreement. This included working on reviewing the definitions of Climate Financing, the work related to Article 2 paragraph 1 (c) of the Paris Agreement, as well as the Report on the duplication of Financing for Adaptation. Other topics covered referred to the SFC Forum on "Fair Transition Financing," as well as a review of the "Guide for operating financial institutions including the financial mechanism."

Bozzo noted how these stages of the project focused mainly on the design, improvement and complementation of the proposals with the contribution of the countries' representatives.

From the perspective of the beneficiary countries, it will be important to know how the benefits will be "capilarized" in such a way to reach all the existing economic units in the countries.

In this sense, MSMEs should be at the center of the projects since they are a very important echelon to reach most of the population, since they represent the vast majority of the existing economic units, where the largest amount of employment is also concentrated. This is even more relevant in the least developed countries where MSMEs can represent very close to 100% of existing companies.

On conclusion of his participation, the WUSME Ambassador also stressed that "There is a high and growing expectation about these projects around the climate and the implementation of them is key. To ensure the success of these programs, it will be essential to carry out different pilot projects and in all the beneficiary countries, in order to verify on the ground how the project behaves in relation to permeating the different bureaucratic barriers that can be faced in the countries, so that the resources reach the objectives of the project in the expected time, in the appropriate quantities and ensuring that they have successful results."

# Meeting between WUSME President Barbara Terenzi and WUSME Ambassador in Chile Alessandro Bozzo

WUSME President Barbara Terenzi met WUSME Ambassador in Chile Alessandro Bozzo on occasion of his visit in Milan on 17 October 2023.

During the meeting, discussion covered mainly initiatives and measures to have a real impact on SMEs, particularly in less developed countries and with a focus on projects related to climate change, also in view of WUSME's participation in the COP.

One of the ideas suggested by Bozzo, as SMEs finance expert and a World Bank Consultant, has been to create a guarantee system to encourage the financing of SMEs at international level, using the best practices deriving from guarantee models already successfully tested in different parts of the world.

#### WUSME at UNCTAD World Investment Forum 2023 to Address SMEs Internationalization

WUSME participated in the 8th *World Investment Forum* held on October 16-20 in Abu Dhabi, United Arab Emirates with the contribution of the Board Member Vinod Kumar to the SME Internationalization roundtable on "Promoting FDI by SMEs".

The session brought together policymakers, business leaders and representatives from international organizations to explore the challenges and opportunities associated with the internationalization of SMEs. The panel discussed how to reduce the common investment policy bias in home and host countries towards large MNEs, the role of SMEs in South-South and intra-regional FDI, and ways and means to maximize the development impact of SME-FDI.

Kumar highlighted how internationalization can be an important strategy for the survival, growth, and long-term viability of SMEs, however, the uncertainties and resource demands associated with foreign investments hinder their international growth.

WUSME promotes international cooperation, fostering linkages between SMEs, governments, institutions and value chains; promotes the creation of business alliances and strengthening the international networks that shall originate opportunities for international trade of SMEs, enabling them to reap the benefits of globalization.

#### Participation of WUSME at COP28

WUSME, the World Union of Small and Medium Enterprises took active part in the COP28, held in Dubai (UAE) from 28 November to 12 December, contributing to the proceedings with an official Exhibit and Side Event on the theme MSMEs facing the energy transition.

The WUSME Delegation attending the COP28 was composed of Madam President Barbara Terenzi, WUSME Directors Mr. Michel Fossaert, Dr. Juneja and Dr. Lam, WUSME Representative in the UAE and Member of the Permanent Commission on Economic and Financial Issues Mr. Muhumed Hussein Diblawe and Ms. Maria Valeria Pasquini, Representative of the WUSME San Marino HQ Representative.

The Exhibit, which took place from 1 to 3 December in the Blue Zone in collaboration with ANDE, the Aspen Network of Development Entrepreneurs of the Aspen Institute, focused on "MSM*Es and Crafts facing the energy transition: technology and financial best practices"* and allowed the WUSME Representatives networking with international delegates to collect inputs and proposals for the development of future collaborations in climate action.

The Side Event, which was held on 3 December in the Blue Zone, explored the theme "MSMEs facing the energy transition: innovative solutions in finance and technology for value chains". Conducted by WUSME in collaboration with the Association Française des Entreprises pour l'Environnement (EpE) and the Regional Center for Renewable Energy and Energy Efficiency (RCREEE), the panel discussion gathered Speakers from various regions and fields.

WUSME President Barbara Terenzi and Directors Mr. Fossaert, Dr. Juneja and Dr. Lam, who took the floor on behalf of WUSME, highlighted the crucial role of MSMEs, in the economies of both



developed and developing countries as drivers of economic growth and employment, as well as the importance of technologies and innovations necessary to promote the green transition and sustainable development, drawing attention also to the many challenges MSMEs have to face in this pathway and the need to identify adequate solutions, especially in the field of finance and investments.

On invitation of WUSME, guest Speakers also contributed to the panel, such as Ms. Xiaolei Zhao, Head of the UNIDO ITPO of Shanghai and Dean of ISID Institute of Shanghai Jiao University, Mr. Bertrand Piccard, Chairman at the Solar Impulse Foundation, and Dr. Arthur Minsat, Head of the Africa, Europe and Middle East Unit – Senior Economist at the OECD Development Centre.

Many and diverse the topics addressed during the Side Event.

Panelists highlighted the need to adopt a new narrative for the climate action and to include adaptation & decarbonization in the framework, strategy and action of businesses.

An overview on how SMEs are facing climate change, with particular focus on MENA and African countries, was also presented.

Panelists also stressed the importance of having an innovative & entrepreneurial clean tech ecosystem to empower green transition of SMEs, shared insights on the Technology & Innovation for and by SMEs to face Climate Adaptation and Energy Transition, emphasized the need for big corporate groups to collaborate with and in support of SMEs, as strategic partners of their value chain in the decarbonization journey through innovation and technology, collaborating alongside public institutions in targeted initiatives and in a mutual partnership logic.

Finally, the importance to mobilize climate finance, promote ESG investments and foster digital/green technology development was recalled for more and faster contributions towards achieving the green transformation of the world's economy.

In particular, the 5-day program encompassed different sessions addressing areas also covered by WUSME in its official Side Event and Exhibit of WUSME at COP28 "sustainable supply chains: Achieving fair globalization", "Climate action: accelerating netzero and climate resilient industrial development", "Building resilient supply chains for the energy transition" and "Driving a just hydrogen transition: Key enablers for clean hydrogen uptake and derisking of investments".
